IT IS CONSIDERED, ORDERED AND ADJUDGED BY THE COURT:

Defendant is to serve a sentence of 12 hours / days / months, consisting of 12 hours/days/months in confinement, credit for 1 hours / days / months already served, and the remainder on Probation.

PROVIDED THAT:

- () 1. The defendant, having been granted the privilege of serving all or part of the above-stated sentence on probation, hereby is sentenced to the following general conditions of probation: (A) not violate the criminal laws of any governmental unit; (B) avoid injurious and vicious habits- especially alcohol intoxication and narcotics and other dangerous drugs unless prescribed lawfully; (C) avoid persons or places of disreputable or harmful character; (D) report to the Probation Officer as directed and permit each Officer to visit him/her at home or elsewhere; (E) work faithfully at suitable employment insofar as may be possible; (F) not change his/her present place of abode, move outside the jurisdiction of the Court, or leave the State for any period of time without prior permission of the Probation Supervisor; (G) support his/her legal dependents to the best of his/her ability.
- () 2. Payment by defendant of the fine and costs in the amount of \$ _____, and restitution in the stipulated amount of \$ _____, shall be a condition of probation.
- () 3. The defendant shall perform _____ hours of community service at times and places specified by the Probation Office.
- () 4. The defendant shall report to the DeKalb County Jail on _____ at _____ o'clock (a.m.) (p.m.).
- () 5. Defendant is to attend a Risk Reduction Program and/or undergo alcohol and/or drug evaluation and treatment as directed by the Probation Office, and/or attend AA / NA _____ times a week for _____ months, and show proof of same to the Probation Office.

Personally appeared the undersigned prosecutor, E S Ford who, on oath, says that, to the best of the prosecutor's knowledge and belief, the above named accused, between 5/12/2007 at 12:00 and 5/12/2007 at 12:00, did commit the offense of Interfere Custody Misd (Misdemeanor) in violation of O.C.G.A .16-5-45 , at 3542 Chamblee Dunwoody Road, Atlanta , DEKALB COUNTY, Georgia, and against Genevieve Patterson and the laws of the State of Georgia. The facts this affidavit for arrest is based on are: said accused did, without lawful authority, knowingly assisted a minor child under the age of seventeen (17) years: [REDACTED] obtain an abortion. June 21, 2007...I contacted the parents of [REDACTED] regarding an Incident Report filed on June 14, 2007. In said report, it is alleged that a person known to them as Cindi Cook persuaded their daughter [REDACTED] to have an abortion without parental consent.

Mr. [REDACTED] told me that [REDACTED] became pregnant sometime in May, 2007. He said that [REDACTED] did not initially tell her parents that she was pregnant but told them after she had an abortion at the Northside Women's Clinic located at 3542 Chamblee Dunwoody Road, Chamblee, Georgia 30341. [REDACTED] told her parents that once she became pregnant, Cindi Cook the mother of her boyfriend intervened. [REDACTED] told Mr. [REDACTED] that Cindi Cook told her not to tell her parents that she would take care of everything and set up the abortion.

Cindi located an abortion clinic (Northside Women's Clinic) that would allow a minor to obtain an abortion with a parental consent note (parent presence not required). Cindi Cook signed a Consent Waiver authorizing the abortion and paid for the abortion.

On May 12, 2007 [REDACTED] went to the Northside Women's Clinic with her boyfriend and presented the Parental Consent Waiver signed by Cindi Cook and had the abortion.

[REDACTED] told her parents about the whole incident on June 12, 2007.

I told Mr. [REDACTED] that I needed an Authorization for Disclosure of Medical Records signed by [REDACTED] in order to obtain a copy of the waiver signed by Cindi Cook.

June 25, 2007...I received a signed Authorization for Disclosure of Medical Records signed by [REDACTED]. I later presented said authorization to the Northside Women's Clinic and obtained a copy of the signed Parental Consent.

June 26, 2007... I spoke with Cindi Cook regarding the incident. She admitted signing the form and paying for the abortion.

June 27, 2007... I met with Judge Anderson of the Dekalb County Magistrate and obtained Criminal Arrest Warrant 07W12052 on Cindi Cook for Interference w/Custody w/Special Conditions to Stay Away.
