## SUBJECT: NOTIFICATION OF UPCOMING BUSINESS INSPECTIONS

Dear City of Oakwood Business Owner/Operator:

In accordance with State and Federal mandates, City of Oakwood's Stormwater Management Program has developed and implemented an Illicit Discharge Detection and Elimination (IDDE) Program designed to identify and eliminate non-stormwater discharges to the City's storm sewer systems and receiving streams. A "non-stormwater discharge" includes (but not limited to): litter; used oil; grease; paint; cleaners; degreasers; garbage; sewage; fertilizer; pesticides; and gasoline; etc.

Beginning in September 2008, City staff and representatives will begin the non-residential inspection phase of this program for local businesses. Potential pollution sources identified as a result of the on-site inspection will be brought to the business owner/operator's attention along with requirements for corrective action. Attached to this letter is an example Business Inspection Checklist that will be completed at each inspection. Businesses who choose to not to comply with local ordinances prohibiting illicit discharges may be subject to additional actions including a fine up to \$1,000 per day. Over time, all businesses with the potential for polluted stormwater runoff to City of Oakwood's storm sewer system and area streams will be inspected and provided educational material on how to protect local streams.

You can prepare for the upcoming inspection by cleaning up all litter and spills on your property, properly disposing of all contaminated soils and gravel and moving potential sources of stormwater pollutants under cover.
