AND THE GRAND JURORS, aforesaid, in the name and on behalf of the citizens of Georgia, charge and accuse **CHRISTOPHER DONTRESE SLAUGHTER** with the offense of **FELONY MURDER**, for that the said accused in the County of Hall and the State of Georgia on the **5TH DAY OF OCTOBER, 2009**, did while in the commission of a felony, to-wit: Aggravated Assault with a deadly weapon as alleged in count three of this indictment, a violation of O.C.G.A. § 16-5-21(a)(2), cause the death of Aikeem Elijah Hall, a human being, irrespective of malice, by shooting him in the chest with a handgun in violation of O.C.G.A. § 16-5-1 (c), contrary to the laws of said State, the good order, peace and dignity thereof.
