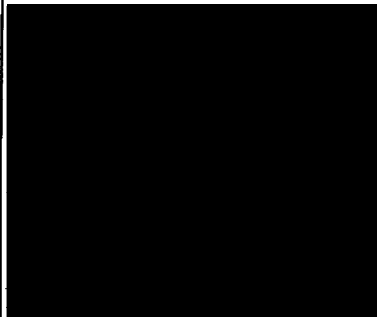

In the name and on behalf of the citizens of Georgia, charge and accuse **DWAYNE CURTISS SEIBEL** with the offense of **CRIMINAL ATTEMPT TO COMMIT KIDNAPPING**, for that the said accused in the County of Hall and the State of Georgia on the **1ST DAY OF NOVEMBER, 2009**, did with intent to commit the crime of Kidnapping, O.C.G.A. § 16-5-40, perform acts, to-wit: the accused approached [REDACTED] a child under 14 years of age who did not know the accused, and the accused directed said child to get into a vehicle being driven by the accused, which constituted substantial steps toward the crime of Kidnapping, which is defined as stealing away and abducting a child under 14 years of age without lawful authority and holding said child against his will; contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT FIVE

AND THE GRAND JURORS, aforesaid, in the name and on behalf of the citizens of Georgia, charge and accuse **DWAYNE CURTISS SEIBEL** with the offense of **LOITERING**, for that the said accused in the County of Hall and the State of Georgia on the **1ST DAY OF NOVEMBER, 2009**, did loiter and prowl in a place, to-wit: the Overlook at North Hall subdivision and Trojan Drive, at a time and in a manner not usual for law abiding individuals under circumstances that warrant a justifiable and reasonable alarm and immediate concern for the safety of persons and property in the vicinity in violation of O.C.G.A. § 16-11-36, contrary to the laws of said State, the good order, peace and dignity thereof.
