PETITION TO DETERMINE SUFFICIENCY OF APPLICATION FOR RECALL
PETITION

COMES NOW, **CRAIG LUTZ** (hereinafter "Lutz"), by and through the undersigned attorney, and files this Petition and shows the Court the following:

1.

Lutz is the duly elected Commissioner for the County of Hall, District 1. He has been serving in such position since January 1, 2011. Chairperson Kevin Kanieski (hereinafter "Kanieski"), who lists his residence as 5572 Old Winder Highway, Braselton, Georgia 30517, is the Chairperson of an effort to recall Lutz and hold a recall election for Hall County Commissioner District 1, and according to the address Kanieski lists, is a resident of Hall County Commission District 1. However, Lutz has good reason to believe that Bobby Husley, who is not a resident of Hall County District 1, is the true Chairperson of the recall effort, and Kanieski is a mere straw man used by Hulseley who has held himself out publically to be heading the recall process.

2.

On or about August 5, 2011, Kanieski, or other person or persons unknown to Lutz, obtained a blank Application for Recall Number CL-001 (hereinafter "Application") from

the Hall County Election Superintendent, Interim Director, Charlotte Sosebee (hereinafter "Sosebee"). A true and correct copy of the Application for Recall (including all 28 pages) is attached to this Petition as **Exhibit A**.

3.

On or about August 18, 2011, Kanieski filed the Application with Sosebee. *See* Exhibit A. The Application, having been filed with Sosebee, cannot now be amended or supplemented. O.C.G.A. § 21-4-5(g). Sosebee did not state whether any persons asked to withdraw their name from the Application, and therefore Lutz has a good faith belief that no Sponsor has withdrawn their name. This Application is insufficient and should be dismissed or denied by this Court.

4.

There are irregularities in the Application that should render the Application void. Sosebee failed to check whether each signer of the Application was a qualified Elector eligible to sign the Application. According to Sosebee, she started on the first page of the Application and checked signers until she reached 100. If the entire application should not be stricken, then the particular page of the Application or the specific Sponsor should be stricken from the Application. However, because Kanieski has committed some of the irregularities, and because Kanieski is both the Chairman of the Application and the Circulator of 6 pages of the Application, the irregularities go to the core of the process and the entire Application should be dismissed or denied.¹

(a) Each Application shall contain the signature, printed name, date signed, residence address, and county residence of each Sponsor. O.C.G.A. § 21-4-5(b)(1)(B).

¹ None of the Sponsors on the pages where Kanieski was the Circulator and Chairperson were counted by Sosebee.

However the Application contains several Sponsors that have not met this requirement and should be stricken.

(b). No notary public may sign the Application as an Elector. Any and all pages of an application that are notarized by a notary public who signed one of the pages of the Application as an elector shall be disqualified and rejected. O.C.G.A. § 21-4-5(b)(1)(E)(ii). One or more of the pages of the Application violate this code section and should be disqualified and rejected.

(c). A person who signs his or her name more than once for the same recall Application shall be guilty of a misdemeanor. O.C.G.A. § 21-4-20(c). One or more of the Sponsor signatures appear to Lutz to be duplicates.

(d). A person who signs any name other than his or her own to a recall Application shall be guilty of a misdemeanor. O.C.G.A. § 21-4-20(c). One or more the signatures on the Application appear to be written by the same hand and should be disqualified and rejected.

(e). A person who signs an application while knowing that he or she is not a qualified elector of the electoral district of the officer sought to be recalled shall be guilty of a misdemeanor. O.C.G.A. § 21-4-20(c). The elections superintendent shall determine if the signers are qualified electors eligible to sign the application. O.C.G.A. § 21-4-5(f)(2). One or more of the signers of the Application were not eligible to sign the application, and upon information and belief, Lutz believes that they knew at the time of signing the Application that they were not registered to vote for Hall County Commission 1, and those signatures should be disqualified and rejected. Sosebee disqualified thirty-nine signers of the

Application as designated on pages 1 through 16 of the Application by the absence of a check mark.²

In addition, Kanieski and each of the circulators have deposed under oath that “each person sponsoring or signing the recall application of [Craig Lutz] is an elector of the electoral district of the officer sought to be recalled.” *See* Exhibit A; O.C.G.A. § 21-4-5(b)(E)(ii). Thus for each of the 39 signers that were disqualified, Kanieski and the Circulator have committed a felony punishable by 1 to 5 years in prison. O.C.G.A. § 16-10-71. Although Sosebee has already disqualified those 39 signers in determining the proper count of Sponsors, the number is so large and the violation so great that it taints the entire process and the entire Application should be disqualified and rejected.

(f). Every elector signing an application shall do so in the presence of the person circulating the petition. *See e.g.*, O.C.G.A. § 21-4-8(b); Exhibit A. The application shall contain an affidavit of the person circulating the recall application. O.C.G.A. § 21-4-5(b)(E)(i). One or more of the signatures were obtained by someone other than the petition circulator or chairman in violation of law. Because an affidavit that misrepresents the name and address of the circulator amounts to intentional misrepresentation of a material fact under oath by the Circulator and the Chairman, then entire the Application should be disqualified and rejected.

5.

Lutz concedes that the Application has correctly presented the statutory grounds for recall as required by O.C.G.A. § 21-4-3(7)(B), as those grounds are pre-printed on the form provided by Sosebee. However, this Court must determine if the facts alleged are facially sufficient to support those listed grounds. Lutz asserts that he has never committed an act of

malfesance while in office, has never violated his oath of office, and has never committed an act of misconduct in office, he denies there is a statutory grounds for recall, and he denies each and every fact alleged in the Application and requires strict proof thereof. The burden of proof is upon Kanieski as the Petition Chairperson to prove that the facts as alleged are legally sufficient, and whether there is probable case to believe that the alleged facts are true. O.C.G.A. § 21-4-6(f).

6.

This Court must determine if the facts as alleged in the Application are legally sufficient grounds for recall according to the statutory definition. The facts asserted may not be mere conclusions. The “facts” in the instant case are mere conclusions and don’t state a sufficient ground for recall.

(a). The first factual allegation is: “Violated Georgia Open Meetings Law.” Without stating how the open meetings law was violated, that Lutz violated the open meeting law, and what harm resulted from any alleged violation, this allegation is legally insufficient as a mere conclusion.

(b). The second “factual” allegation is: “Mr. Lutz and two other commissioner [sic] did contractual work prior to it being voted on by the entire board.” Even assuming the fact to be true, it is not unlawful for Lutz to do contractual work with or without other commissioners. In addition, discretionary performance of a lawful act shall not constitute a ground for recall of a public official. O.C.G.A. § 21-4-3(7)(B). Therefore this factual allegation is legally insufficient.

(c). The third “factual” allegation is: “Mr. Lutz and two other commissioners fired the three administrators without it being voted on by the entire board.”³ Discretionary performance of a lawful act shall not constitute a ground for recall of a public official. O.C.G.A. § 21-4-3(7)(B). Hiring and firing decisions are completely within the discretion of the Commissioner, and therefore this factual allegation is legally insufficient.

7.

Finally, if this Court finds that the allegations if true are legally sufficient, then this Court must determine whether the allegations are stated with reasonable particularity. The Application fails to state allegations with specificity so that they put Lutz, or the public, on notice of the alleged prohibited conduct to the extent that the public would understand the basis for a petition for recall and to which Lutz would be able to respond.

(a). The first factual allegation is: “Violated Georgia Open Meetings Law.” The “fact” is not stated with particularity. The date of the alleged violation is missing, and any meeting was not adequately described, and as a result renders the “fact” insufficient.

(b). The second “factual” allegation is: “Mr. Lutz and two other commissioner [sic] did contractual work prior to it being voted on by the entire board.” Again, the fact fails to identify the date of the alleged misconduct and the “work” alleged to have been conducted. Without that key information, the “fact” is legally insufficient.

(c). The third “factual” allegation is: “Mr. Lutz and two other commissioners fired the three administrators without it being voted on by the entire board.” First, the date of the “firing” is not stated; second, it does not list who the “three administrators” are; third,



it fails to state that a vote of the board is required for the "firing." Without this key information, the "fact" is legally insufficient.

Because none of the "facts" alleged are stated with reasonable particularity, they are legally insufficient.

WHEREFORE, Lutz requests that this Honorable Court review the Application and (1) DENY the Application for Recall, (2) DISMISS the Recall Petition, (3) FIND that the grounds listed in the Application are meritless and there is no probable cause to support them, and (4) any and all other such relief that the Honorable Court sees fit including attorneys fees and court costs.
