**A RESOLUTION CONSENTING AND AGREEING TO THE  
ANNEXATION BY THE CITY OF OAKWOOD, GEORGIA OF CERTAIN  
ROADS AND STREETS ADJACENT TO THE CITY OF OAKWOOD  
PURSUANT TO O.C.G.A. SECTION 36-36-20(b) AS SET FORTH IN  
EXHIBIT “A” ATTACHED HERETO AND FOR OTHER PURPOSES**

**WHEREAS**, the Mayor and City of Oakwood have requested that the Hall County Board of Commissioners consent and agree to the annexation of certain roads and streets adjacent to the City of Oakwood as set forth in Exhibit “A” attached hereto by resolution expressing the County’s agreement to the said annexations as authorized by O.C.G.A. Section 36-36-20(b); and

**WHEREAS**, it appears that the annexation of said roads and streets by the City of Oakwood is conditioned upon the City of Oakwood assuming all maintenance and repair of said roads and streets, thereby relieving Hall County of said obligations, a condition accepted by the City of Oakwood; and

**WHEREAS**, it further appears that annexation of said roads and streets by the City of Oakwood is conditioned upon the City of Oakwood agreeing to not use the “island annexation” method of annexation that might be possible as the result of the annexation of said roads and streets by the City of Oakwood; and

**WHEREAS**, the City of Oakwood is desirous of annexing said roads and streets into the City of Oakwood to simplify public safety responses by eliminating confusion resulting from said roads and streets having multiple portions of the roadway being in both incorporated and unincorporated areas of the county; and

**WHEREAS**, the City of Oakwood is further desirous of annexing said roads and streets as a component of the Oakwood 2030 Plan so as to potentially link the City of Oakwood to Lake Lanier and thereby enhance recreational options in the City of Oakwood and south Hall County in general; and

**WHEREAS**, O.C.G.A. Section 36-36-20(b) authorizes the annexation of said roads and streets with the consent and agreement of Hall County, Georgia; and

**WHEREAS**, the City of Oakwood has undertaken an extensive education program concerning linking the City of Oakwood to Lake Lanier by soliciting input from citizens in the affected area as set forth in the Community Engagement Report attached hereto as Exhibit “B”; and

**WHEREAS**, the City of Oakwood has compiled a summary of attendance and commentary at two town hall meetings held in the City of Oakwood on November 15 and 17, during which no objections were raised to the proposed annexation of the attached roads and streets so as to link the City of Oakwood to Lake Lanier;

**NOW, THEREFORE, BE IT RESOLVED**, by the Hall County Board of Commissioners and it is hereby resolved by the authority of the same as follows:

Upon motion, second and approval of the Hall County Board of Commissioners, Hall County hereby consents and agrees to the annexation of the roads and streets set forth in Exhibit "A" attached hereto as authorized by O.C.G.A. Section 36-36-20(b).
